Information sheet on Tuberculosis examination for long term UK visa applicants in Nigeria

Dear Visa Applicant;

You will be able to obtain a medical certificate at the International Organization for Migration (IOM), Migration Health Assessment Centre in Abuja and Lagos. You will need to obtain a medical certificate confirming that you are free from active tuberculosis (TB) if you are applying for a visa to travel to the United Kingdom (UK) for **longer than six months**. The following individuals will not require obtaining a medical certificate: diplomatic passport holders traveling on official business or on a posting to the UK, those who qualify for exempt visa, those applying for a certificate of entitlement and returning residents. If you are traveling with child(ren), you are required to come with the child(ren) for medical examination as well.

Payment modalities

Payment can be made through a bank deposit in any of the Standard Chartered Bank branches in Nigeria or through a bank transfer. You will be requested to present proof of payment (statement) when reporting for medical examination. The all-inclusive non-refundable fee is **NGN 48,900** (Forty eight Thousand and nine Hundred Naira) for each visa applicant **aged 11 years or more** and **NGN 19,600** (Nineteen thousand six hundred Naira) for each **child under 11 years**. The all-inclusive non-refundable fee for **certificate re-issuance** is **NGN 8,200** (Eight thousand and Two Hundred Naira only). The examination fee is periodically adjusted depending on the local currency fluctuation. Please call IOM to confirm the amount to pay before making payments.

NOTE:

- a) If you are paying by a bank transfer, please remember to allow enough time (**2-3 days**) for the payment to go through to the receiving account before the scheduled appointment date and bring along a clear evidence of payment. It can take from 1 to 3 days for the funds to appear in the receiving account. Please note that you will be issued a certificate only when your payment has been debited in the IOM account and not necessarily on the same day of medical examination.
- b) During the peak season (July – September), please expect on average a **waiting time of 10 working days** from the appointment request date. Plan your medical examination well in advance to avoid last minute rush.

Required identification and registration documents:

1. Identification documents
 - a. Valid international passport or
 - b. UNHCR registration document/ Alien card (refugees and asylum seekers).
2. Proof of payment (statement).

Step-by-step procedure:

1. For enquiry on medical examination procedure, call the IOM Migration Health Assessment Centre using the above telephone numbers or send an e-mail to the above e-mail addresses.
2. Pay the examination fee using the above bank details and obtain proof of payment (statement).
3. Report to the IOM Migration Health Assessment Centre at the times indicated above for registration and medical examination. Ensure to come with a valid identification document and proof of payment.
4. After registration, history will be taken and a chest x-ray requested if you are aged 11 years or more. History will be taken and physical examination performed for children less than 11 years old. Children less than 11 years may undergo a chest x-ray if there is a clinical indication for TB screening.
5. A consent form will be signed before medical examination for each individual. Parents or guardians will sign consent form for individuals below 18 years.
6. Additional tuberculosis tests (sputum smears and culture-**gold standard for TB diagnosis**) will be requested if chest radiograph show abnormalities suggestive of active tuberculosis infection. The TB culture takes **eight (8) weeks** to obtain negative results.
7. If you are diagnosed with infectious tuberculosis, you will be referred for treatment. Tuberculosis treatment is free of charge under the National Tuberculosis and Leprosy Control Program (NTBLCP) and it takes a minimum of six months to complete treatment.
8. Medical certificates will be issued on the same day of medical examination and collection time will be given during the examination.
9. Female applicants of childbearing age may be requested to undergo a **pregnancy test** if they are not sure of their pregnancy status.

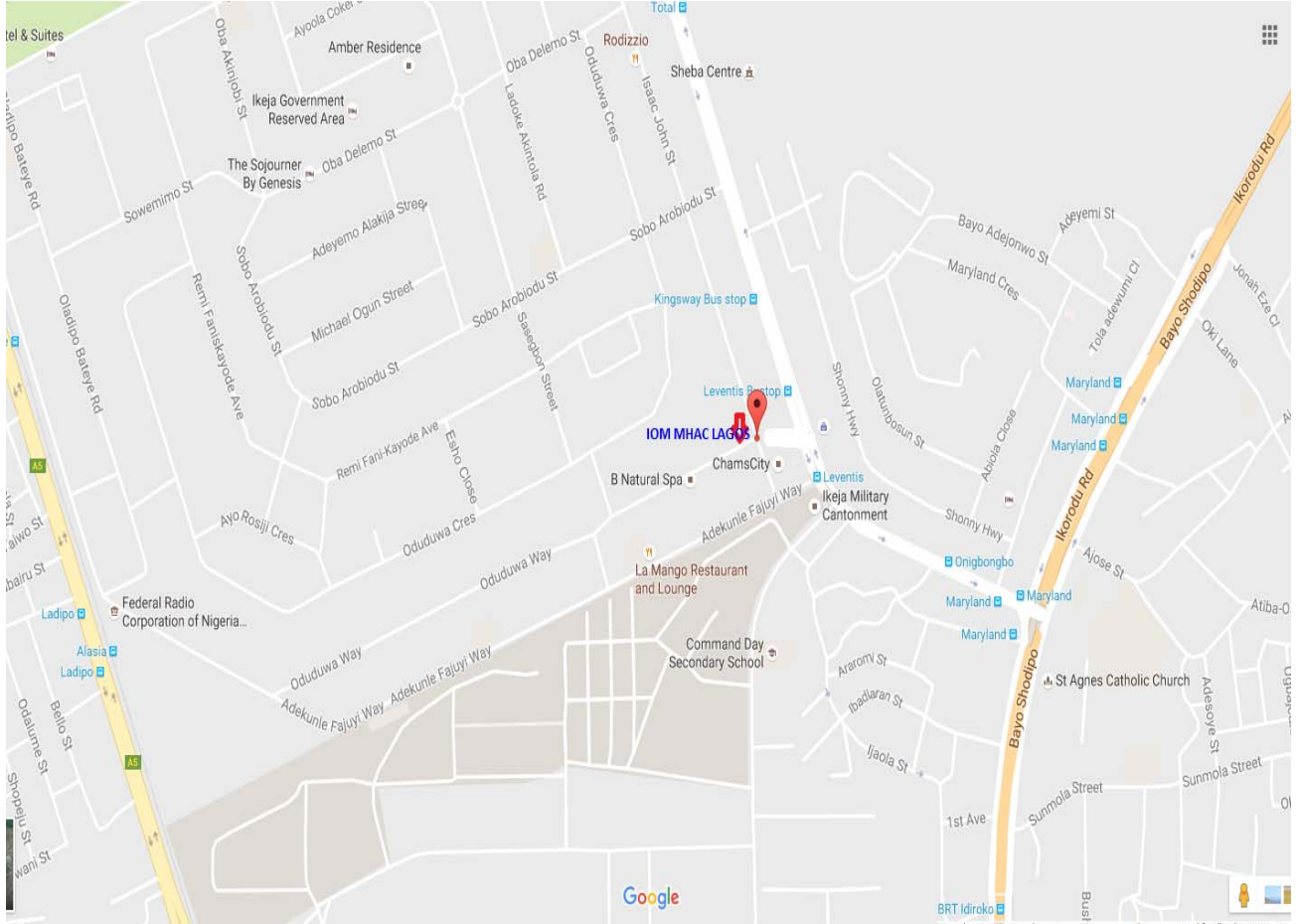
