- Adequate provision of Cold Chambers (2-8 Degrees Celsius).
- Cold Chain Storage during delivery must be maintained, Cold Transport Bags/ Coolers (2-8 Degrees Celsius).
- Data Loggers for monitoring temperature at storage and during transportation of vaccines.
- Manufacturer’s Authorization to distribute vaccines.
- Annual License of Superintendent Pharmacist.
- Certificate of Registration/Retention of Wholesaling/ Distribution Premises.
- Evidence of Standby Generator, or other backup power supply plan.
- The facility should meet the required standards for cleanliness, ventilation, lighting, and waste disposal to ensure the safety and quality of the vaccines.
- The facility should have sufficient workspace for staff to perform their duties efficiently. This includes vaccine storage, inventory management, labelling, packaging, and shipping. Additionally, there should be designated areas for administrative tasks, documentation, and quality control procedures.
- Facility should have adequate security measures to prevent theft, unauthorized access, or tampering. This may include surveillance cameras, restricted access areas, secure storage units, and inventory management systems.
- The vaccine should be listed in WHO prequalified list OR NAFDAC approved list.
