3. Sector(s) and area(s) of specialization

IOM Nigeria’s DTM team is seeking prospective implementing partners to conduct Inter-sector Needs assessment, needs monitoring, and Rapid Assessments in the hard-to-reach locations of the BAY states not currently covered by the DTM unit.

4. Issuing Agency

5. Project Background

The crisis in conflict-affected north-east Nigeria continues to be one of the gravest in the world today, marked by armed conflict, forced displacement and severe violations of civilians’ human rights and dignity. They are the main drivers of vulnerabilities and protection concerns that the vulnerable populations face, including protracted displacement, human rights violations, Gender-Based Violence (GBV) and Sexual Exploitation and Abuse (SEA). Internally Displaced Persons (IDPs) in and outside camps have weak coping mechanisms and rely heavily on humanitarian assistance to survive and improve their living conditions. Despite the efforts of the Nigerian authorities in addressing the crisis in northeast Nigeria and the increased number of humanitarian actors on the ground, the situation remains precarious.

Based on DTM round 37 (August 2021), there were 3,944,677 IDPs and returnees in Northeast Nigeria. Most displaced populations related to the crisis in North-East Nigeria are in the three states of Borno, Adamawa and Yobe – Borno States host 70 per cent (2,005,545 individuals) out of the total number displaced individuals and 1,753,484 individual returnees in the north-east. Out of the displaced population in Borno State, 52 per cent (746,624 individuals) reside in displacement sites (IOM DTM Round 37, August 2021). About 60 per cent of the displaced population across the Northeast reside in host communities, with the majority living in host families. In contrast, others reside in the nearly 298 displacement sites – close to 95 per cent of displacement sites are spontaneous.

The DTM program supports the Government and humanitarian partners by establishing a comprehensive system that collects, analyses, and disseminates data on IDPs and returnees to ensure timely and practical assistance to the affected populations. In each round of DTM assessments, IOM, National Emergency Management Agency (NEMA), State Emergency Management Agency (SEMA) and the Nigerian Red Cross Society (NRCS) staff collate data in the field, including displacement baseline data at LGA and ward-levels. More so, carrying out detailed assessments in displacement sites, such as camps and collective centers, and in locations where IDPs reside among host communities.

Since its establishment in Nigeria in August 2014, IOM’s DTM team has grown with well-trained and experienced DTM enumerators a strong information management structure supporting robust data processing and analysis. DTM’s field presence is based on dynamic and responsive mechanisms, capable of scaling up activities in a short space of time.

Partners rely heavily on DTM products for planning, decision making, service provision, and accountability to the affected population, making DTM one of the enablers to the response in the NE. Through the requests of the ISCG and AAWG, this project aims to gather critical data to provide a comprehensive understanding of the needs and vulnerabilities of crisis-affected persons in BAY states of north-east Nigeria and inform the Humanitarian Needs Overview (HNO) and Humanitarian Response Plan (HRP) for 2023, ISCG and AAWG for more coordinated humanitarian assistance.

6. Expected Results

The proposed activities will include:

- Quarterly Needs Monitoring through the Inter-Sector Needs Assessment with sub-activities of the Joint Intersectoral Analysis Framework.
- JIAF / Inter-sectorial needs assessment.
- Needs Monitoring
- Rapids Assessments (Ad-hoc)

The JIAF is a new approach to analyzing the needs of populations in crisis. The international humanitarian community introduced it into the Humanitarian Programme Cycle in 2020. The JIAF offers a standard method, process, and tools to conduct a “people-centred” holistic needs analysis.

The above activities will contribute to the following immediate outputs.

- a) Output 1.1: JIAF data collection process for the BAY States launched in Coordination with ISCG and AAWG partners.
- b) Output 2.1: Humanitarian needs monitoring is done, analyzed, and reported every quarter for ISCG and IMWG.
- c) Output 2.2: Monitoring tools and methodologies, Analysis reports, data signals are provided to ISCG / AAWG
- d) Output 3.1: ISCG and AAWG have detailed ad-hoc data and reports on initial Rapid needs Assessments.

The data will be disaggregated by gender, age, location and other key indicators for detailed mobility analysis reports and increased knowledge on data collection. The above activities and outputs will contribute to realising the project Outcomes in the long run.

- Outcome 1. Enhanced Inter-Sector Coordination Group (ISCG) data collection and dissemination at the household level to fill the information gap on JIAF indicators in all accessible locations within the BAY (Borno, Adamawa and Yobe) States.
- Outcome 2: Continued monitoring of the humanitarian needs using JIAF indicators integrated into DTM mobility tracking in coordination with the IMWG and ISCG (upon request).
- Outcome 3. Enhanced Initial Rapid Needs Assessment support for ISCG (upon request).

Thus, leading to the broader objective of supporting better programming by providing a comprehensive understanding of the needs and vulnerabilities of crisis-affected people in BAY states of north-east Nigeria and informing the Humanitarian Needs Overview (HNO) and Humanitarian Response Plan (HRP) for 2023, ISCG and AAWG for more coordinated humanitarian assistance.

7. Indicative Budget

The IP should provide an indicative budget for the data collection operation, including staffing, data analysis and reporting for the 12 months period in line with their own budget guidelines and templates. Later on after selection, it would be transformed to IOM/NFH templates.

8. Other Information

The NHF 2021 First Standard Allocation Strategy aims to “provide dignified living conditions for the most vulnerable and crisis-affected people in Borno, Adamawa, and the Yobe States. The allocation will ensure the continuity of essential humanitarian assistance provided through the NHF 2020 Standard Allocation.” DTM proposed activity centres on “Needs Monitoring and Inter- Inter-Sector Needs Assessment” with sub-activities of JIAF / Inter-sectorial needs Assessment, Needs Monitoring and Rapids Assessments (Ad-hoc).

The proposed activities are directly linked with the OCHA/ NHF allocation strategy and the prioritization by Coordination and Support Services and DMS sectors. The prioritized activities under this project will contribute to the below priorities:

- Provide a comprehensive understanding of the needs and vulnerabilities of crisis-affected people in North-East Nigeria
- Inform the HNO and HRP for 2023, ISCG and AAWG for more coordinated humanitarian assistance

Priority areas under this action will include 65 LGAs of the BAY States if and when security permits. The LGAs are as per below;

2. Adamawa: (Demsu, Fufore, Ganye, Girei, Gombi, Guyuk, Hong, Jada, Lamurde, Madagali, Maiha, Mayo - Belwa, Michika, Mubi North, Mubi South, Numan, Shelleng, Song, Toungo, Yola North, Yola South LGA.)
3. Yobe: (Bade, Bursari, Damaturu, Fika, Fune, Geidam, Gujba, Gulani, Jakusko, Karasawa, Machina, Nangere, Nguru, Potiskum, Tarmuwa, Yunusari, Yusufari LGA.)"

The target population for this Allocation are IDPs living in camps and camp-like settings, returnees, host communities and other vulnerable groups. All activities in this proposal are directed towards these specific groups, and thus, are linked to the cluster objectives;

- o SO1: SSO1: "Provide enhanced coordination services to ensure timely, effective and principled assistance and protection services to conflict-affected people in Borno, Adamawa and Yobe states of Nigeria,"

With Strategic Response Plan;

- o SO1: Save lives by providing timely and integrated multi-sector assistance and protection interventions to the most vulnerable.

To ensure we reach more expansive locations, the local partner to be hired will ensure continuity and increased coverage to areas or locations the UN system is not allowed to access. This will see a more in-depth understanding of these locations to gather appropriate information for support. IOM DTM will work closely with the chairs of IMWG and AAWG throughout the project period to ensure tools, methodology, and procedures are well adapted to the members' needs. This will ensure acceptance and usability of the data to support making informed decisions.

The activities implemented throughout will be initiated/activated through approvals from the ISCG, AAWG and IMWG before commencing to ensure timelines and guidelines are strictly adhered to. All equipment purchased for data collection will be under the custody of the chair/coordinator of AAWG; this will ensure ease of access to the same and can be loaned to members of the AAWG in a short period.
